7. <u>Delegated Powers</u>

RESOLVED that, the Clerk, as Proper Officer of the council under the Scheme of Delegation within the High Infectious Diseases Policy and Standing Orders, continues to have delegated authority to make decisions on behalf of the council where such decision cannot reasonably be deferred and must be made in order to comply with a commercial or statutory deadline. This delegated authority ceases upon the first meeting of the council after the council meeting at which the delegation was put in place. Any actions taken under the authority must be reported at that meeting.

8. <u>Clerks/District Councillors Reports – for information</u>

Clerk reported that:

- ٠ Many reports are being made of unkempt trees, grass, and hedges. Landowners reminded of their responsibilities and reported to B&NES as appropriate.
- PCAA have taken a vote on holding virtual meetings and have decided none are to be held at present as ٠ little activity.
- Data Protection registration is due for renewal 8th July 2020
- Cessation of LCPAS means new Data Protection Officer will be appointed, and an alternative body may ٠ be required. Clerk to explore and report back to Parish Council by 1st July 2020.
- Bittern Trail has had to be closed at Chew Valley Lake due to diseased trees at serious risk of falling • creating high risk to the public. The Alder tree species in this woodland is suffering from an aggressive disease that weakens the roots/plates and means the trees are vulnerable to falling.
- Community will be engaged when Bristol Water have explored their options. ٠
- Chew Valley JFC Under 10's training on recreation ground on Saturday mornings •
- Young Bristol due to restart early July
- Stanton Drew Neighbourhood Plan back for consultation as previous version did not meet the • requirements of the Neighbourhood Planning Regulations. Consultation expires 20th July. Clerk to compare to previous version and will advise of changes to determine if SSPC should provide any further comment.
- Great Weston Ride postponed to 20th September 2020

District Councillor Pritchard reported:

- a full Bath & North East Somerset Council meeting took place 16th June 2020 and confirmed a projected • deficit for the financial year of £53m due to Covid-19 pandemic. Discussions underway about spend and how to mitigate before financial year end.
- B&NES are currently creating expanded walk spaces preparing for social distancing as things return
- 'Buzzing signs' available to attract bees to hedges that will not be cut providing habitats and supporting bee recovery
- Request to place lease for Bishop Sutton AFC on the next agenda to prepare for the future operation and extension
